COLONEL WILLIAM T. GIBSON

Colonel William T. Gibson is the Director of Financial Management and Comptroller, Headquarters Pacific Air Forces (PACAF), Joint Base Pearl Harbor-Hickam, Hawaii. As Chief Financial Officer for PACAF, Colonel Gibson is responsible for formulating, justifying, and executing a \$7 billion portfolio. This budget supports 360 aircraft, 46,000 personnel, as well as \$50 billion worth of PACAF assets. He establishes accounting policy and supervises financial reporting to HQ USAF, Office of Secretary of Defense, and the U.S. Treasury.

Colonel Gibson received a Bachelor of Science degree in Business Finance from the University of Maryland College Park, and was commissioned through the ROTC program in 1999. His previous assignments include various levels of comptroller assignments, including commander, cost analyst, budget officer, and executive officer at the base, major command, and air staff levels. Prior to this assignment, he served as the Chief, Budget Operations Integration Division, Deputy Assistant Secretary for Financial Management and Comptroller, the Pentagon, Washington, D.C. where he was responsible for planning and directing the formulation and execution of the Department of the Air Force's operation and maintenance budget totaling more than \$60 billion annually.
