Colonel Corey G. Fullmer serves as the Staff Judge Advocate for Headquarters, Pacific Air Forces, Joint Base Pearl Harbor-Hickam, Hawaii. In this position, he advises the Commander, Pacific Air Forces on all U.S. Air Force matters arising in the Pacific Theater. In addition, he provides counsel on joint-matters arising from the Commander's role as the Theater Air Component Commander for U.S. Indo-Pacific Command. Additionally, he supervises the activities of more than 260 legal personnel in 15 legal offices supporting PACAF commanders and more than 100,000 PACAF Airmen and dependents.

Colonel Fullmer is from Star Valley, Wyoming, and received a direct commission as an Air Force officer in August, 2001, entering active duty on September 4, 2001. In 2005, he deployed to Bagram Air Base, Afghanistan in support of Operation Enduring Freedom.
